## CITY OF SMYER UTILITIES PRIVACY POLICY

**TYPE OF INFORMATION WE COLLECT:** The City of Smyer's Utility Department provides water supply, wastewater disposal, and solid waste disposal services. The City requires certain personal identifying information, including name, address, telephone number, Social Security number and driver's license or state issued personal identification numbers.

USES OF PERSONAL IDENTIFYING INFORMATION: We use this information to open customer utility accounts, maintain the accounts, and if necessary, to collect amounts owed.

HOW WE OBTAIN THIS INFORMATION: We obtain this information from the customer.

WHERE WE KEEP THIS INFORMATION: All personal identifying information maintained by the city is maintained at City Hall in a manner that is not accessible by the public and is accessible only to those employees of the City whose duties require that they have access.

TO WHOM WE DISCLOSE THIS INFORMATION: The City does not disclose this information to anyone other than (1) City employees whose duties require that they have access, (2) entities with whom the City has agreements for the collection of unpaid and delinquent accounts, and (3) law enforcement agencies to the extent necessary for them to perform their duties.

**HOW THIS INFORMATION IS DISPOSED OF:** When this information is no longer needed, the records are destroyed.
